

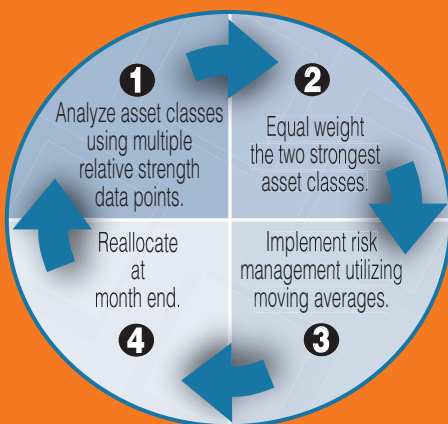


Description

The alternative bond strategy is a rules based global bond fund that employs an equal weighted strategic rotation model allocating between seven broad based non-correlated fixed income asset classes.

The Strategy utilizes a risk management tool that allows 100% cash and inverse Treasury exposure during bond market declines.

Process



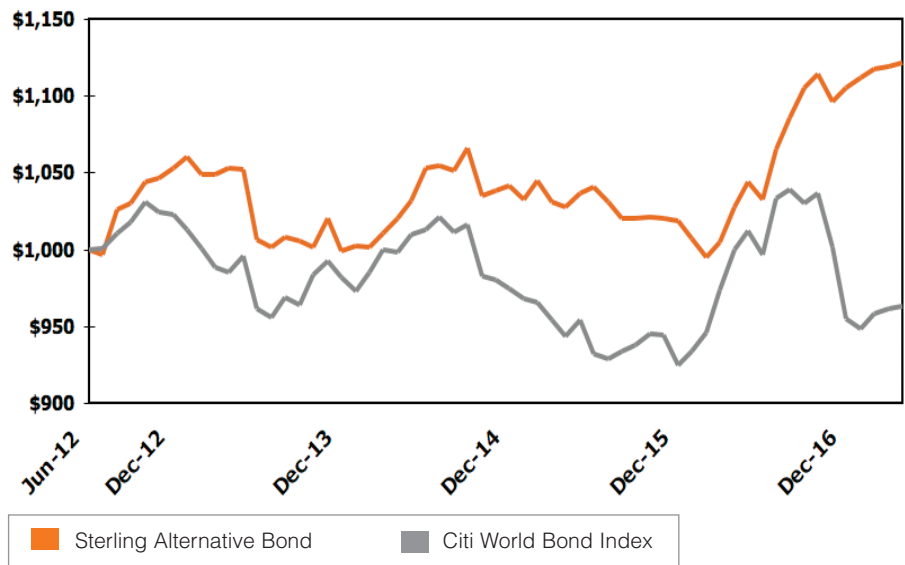

Sterling Global Strategies LLC (SGS) is an independent registered investment advisor. For GIPS purposes, the firm

includes all SGS discretionary assets, including assets previously managed by Sterling Wealth Management Group, Inc., with the exception of Comprehensive Financial Management advisory assets. The firm maintains a list of composite descriptions, which is available upon request.

Based on Sterling Global Strategies’ belief that we may be at the tail end of a 30-year bond bull market and will experience a possible rise in interest rates over the next 15 to 25 years, SGS launched the Sterling Alternative Bond strategy in May 2012. The alternative bond strategy attempts to perform well during a rising interest rate environment and was created by adding an inverse 20+ year Treasury ETF to the Sterling Tactical Bond Strategy. The Sterling Alternative Bond Composite was created in November 2012. The U.S. Dollar is the currency used to express performance.

The investment management fee schedule begins at a 2.00% flat fee per annum, on all assets under management. Actual investment advisory fees incurred by clients are negotiable, and may vary. Further information regarding investment advisory fees is described in Part II of the firm’s Form ADV.

The benchmarks for the composite are the Barclays U.S. Aggregate Bond Index and the Citigroup World Government Bond Index. The Barclays U.S. Aggregate Bond Index, is a broad based index representative of the U.S. investment grade bond market and including Treasury, Agency, Mortgage Backed and Corporate Bonds. The Citigroup World Government Bond Index includes 23 markets selected based on market size, credit and barriers-to-entry. One cannot invest directly in an index.

Past performance is not indicative of future results. Performance shown represents total returns that include income, realized and unrealized gains and losses.

Gross performance is presented net of transaction costs as well as custodial fees. Net of fee performance has been calculated by deducting an annual fee of 1.25%, on a quarterly basis. Composite performance is presented net of foreign withholding taxes that are implicit in the funds held in the portfolio. Policies for valuing portfolios, calculating performance, and preparing compliant presentations are available upon request.

The annual composite dispersion presented is an asset-weighted standard deviation calculated using accounts in the composite the entire year. The 3-Year Standard Deviation represents the annualized standard deviation of actual composite and benchmark returns, using the rolling 36-months ended each year-end.
